### TERMS OF UMPIRE SERVICES CONTRACT

#### **SCHEDULES**

League schedules must be delivered to the Federation, within three weeks of the first scheduled game. Failure to provide the Federation with your schedule within this time frame may affect the availability of our umpires working your games. We will do everything in our power to secure umpires for all your games.

#### **SCHEDULE CHANGES**

Schedule changes requested by League Representatives *may* be subject to an Assignment Fee. Discussions regarding schedule adjustments/fees will be made at our discretion.

#### SPECIAL CIRCUMSTANCES:

#### **WEATHER**

The League must contact the Federation three (3) hours before game time to officially **cancel the game** because of weather. Canceling the game will release the scheduled umpires from their assignments. It is the League's responsibility to notify the Federation for day-of-game cancellations. Email notifications will be sufficient 24 hours in advance. Game Fees still apply.

#### **CANCELED GAMES**

The League must contact the Federation three (3) hours before game time to officially cancel a game.

#### **FORFEITED GAMES**

Games forfeited by one or both teams will be considered officiated by the Federation when our umpires are in transit to the field. The plate umpire will be required to send a Forfeit Notification to the President.

#### **CONTINUATION GAMES**

Continuation games scheduled to be played prior to a previously scheduled game will be charged as follows:

• 1 - 3 innings: 50% Game Fee

· 4 or more innings: 100% Game Fee

#### **RULES OF THE GAME**

The Federation umpires will officiate baseball games in accordance with league rules.

#### **GAME FEES**

Game fees will be provided to the League Representative after confirmation of the submitted game schedule. 100% of the game fee will be invoiced.

#### PAYMENT FOR UMPIRE SERVICES

All invoices are due in **14 days**. The final invoice will reflect any adjustments, cancellations, rain outs, and additions to the schedule and will be delivered to you within 21 days after the last scheduled game.

#### LATE PAYMENTS

Failure to pay 100% of the invoice on time may cause the removal of umpires from your schedule.
